TERMS AND CONDITIONS:

RESERVATIONS: Upon your signature Click Click Photography will reserve the time and date agreed upon. For this reason the reservation deposit of 10% of the fee is non-refundable, even if date is changed or wedding canceled for any reason, including acts of God, fire, strike, and extreme weather. The reservation deposit is to be paid at the time the services of Click Click Photography are retained. The reservation deposit is applied towards the fee. The Client understands and agrees that the entire amount owed for the wedding photograph package described in the contract is due no later than two (2) weeks before the wedding date. The Client agrees if the balance is not paid by this time, Click Click Photography will not photograph the wedding day described on the contract with no liability to Click Click Photography and loss of reservation deposit by Client. A \$50 charged is assessed to checks returned for any reason. ***Make all checks payable to: Ralph Cooke.***

PRE-EVENT CONSULTATION: The parties agree to a pre-event consultation before the event date in order to finalize the actual shooting times, locations and Client's request list (in writing) for specific photographs. The Client will be responsible for, or have someone designated (i.e., wedding coordinator) to identify people or gathering people for photograph(s). The bride and groom agree to set aside a reasonable amount of time after the wedding ceremony for photographs that cannot be obtained during the wedding, including group shots.

COOPERATION: The parties agree to cheerful cooperation and communication for the best possible results. Click Click Photography cannot be responsible for lack of coverage caused by errors in instructions given to photographer by the wedding party or church or synagogue restrictions regarding photography.

EXCLUSIVE PHOTOGRAPHER: The photographers of Click Click Photography are the official and exclusive stills photographers of the wedding events. Simultaneous still coverage by another *contracted or professional photographer* releases Click Click Photography from this agreement. Guests may take photographs at the wedding and reception, but cannot obstruct and/or interfere, with the shooting schedule/flow. Click Click Photography reserves the exclusive rights for all formal and other shots set up by its photographer. *It is the Client's responsibility to inform guests of said policy.* This will ensure that photographs are of a consistently high standard; and eliminate unusable shots due to distractions from family and guest attempting to take shots of staged photo shoots.

SHOOTING TIME/ADDITIONS: Click Click Photography agrees to pre-wedding, wedding and the reception and will remain with the bride and groom until released; not to exceed eight (8) hours. Photographic services required beyond that (i.e., hotel arrival) are subject to an additional fee of \$100.00/hour.

LIMIT OF LIABILITY: In the unlikely event of severe medical, natural, or other emergency it could be necessary to retain a different photographer. Click Click Photography will make every effort to secure a replacement photographer. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payment received for the event package.

COPYRIGHT AND REPRODUCTIONS: Click Click Photography shall own the copyrights for the photos created and shall have the exclusive right to make copies of them. Click Click Photography shall only make copies for the Client for the photographer portfolio, samples, self-promotions, entry in photographic contests or at exhibitions. If the photographer desires to make other uses, the photographer shall not do so without first obtaining permission from the Client.

PHOTO MATERIALS: All finished photos can be viewed at Click Click Photography's website in a private, password protected gallery. Cost/pricing for CD and finished photo prints will be determined separate from any pricing contained herein.

TABLE AND SEATING AT RECEPTION: It will be required that the Client honor the photographer(s) for eating first with the wedding party. During the reception an area with table will be clearly designated and set aside for the photographer's use only; and will be in close proximity to the wedding party to capture memorable moments.

This Agreement incorporates the entire understanding of the Parties, and Parties agree to all its terms, and acknowledge receipt of a completed copy of the Agreement signed by all Parties. Any modifications of this Agreement must be in writing and signed by all Parties. Each person signing as Client(s) below will be fully responsible for ensuring that full payment is made to the terms of this agreement.
